- Utilize translator/interpreter for school events

BUILDING CAPACITY OF SCHOOL STAFF

Mundy Mill Academy will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Meet monthly with our School Governance Council to garner feedback for topics of improvement
- Conduct weekly Professional Learning Community meetings with teachers
- Monitoring and effectively notifying parents of student attendance
- Conducting curriculum nights to build ties between home and school
- Send information home in the child's home language

BUILDING CAPACITY FOR INVOLVEMENT
